NOTICE TO EXHIBITORS

1. A recording fee of \$.50 will be required for each dog entered at any Licensed or Member Club Show, Obedience or Rally Trial or Tracking Test. These fees are to be collected by the show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee if to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2). Additionally, a \$3.00 Event Service Fee for each entry will be collected by the show-giving Club and paid to the American Kennel Club.
2. **CONDITIONAL, UNSIGNED, INCOMPLETE OR ENTRIES RECEIVED WITHOUT FEES** will not be accepted.
3. No drinking of alcoholic beverages or smoking is allowed anywhere on the school (show) grounds. Exhibitors and handlers are responsible for clean conditions in and around their crates.
4. Owners are responsible for any errors in completing entry forms (whomever may make such errors) and no entry fee will be refunded in the event of such errors. Information on the entry forms must be clear and legible. **PLEASE PRINT LEGIBLY OR TYPE ALL INFORMATION WHEN COMPLETING THE ENTRY FORM.**
5. Entry fees shall not be refunded if a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge or barred from competition by action of the Obedience Trial Committee. **EXCEPTION:** Refund of entry fee will be made if a female dog "comes in season" before the date of the Obedience Trial, provided the request for the refund is received by the Trial Secretary at least ½ hour before the start of the class that the dog is entered in at the Trial. 100% of the entry fee will be refunded. The AKC fees will not be refunded.
6. If, because of riots, civil disturbance or other acts beyond the control of management it is deemed impossible to open or complete the show, no refund of entry will be made. Extreme weather conditions such as, but not limited to, hurricanes, typhoons, lightning, extreme heat, severe wind and/or rain, must be considered for the health and safety of the dogs, exhibitors and spectators are of paramount importance and in the event it is necessary to cancel or stop the show, no refund of entry will be made.
7. The welfare of an exhibitor's child(ren) is the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their child(ren) on the show grounds.

8. THERE SHALL BE NO DRILLING, INTENSIVE OR ABUSIVE TRAINING OF DOGS ON THE SHOW GROUNDS OR PREMISES. NO PRACTICE RINGS OR AREAS SHALL BE PERMITTED. (AKC Obedience Regulations, Chapter 2, Section 26).
9. The owner or agent entering a dog in this Show does so at his own risk. THE CLUB WILL NOT BE RESPONSIBLE for loss of, or damage to, any dog exhibited. Every dog in the Show is in the care, custody and control of his owner or handler during the entire time the dog is on the show premises. ALL DOGS MUST BE HELD ON LEASH OR CONFINED TO A CRATE EXCEPT WHEN BEING JUDGED.
10. In order to be eligible for a trophy, exhibitors or their agents must stay until the trophy is awarded. The agent must present the exhibitor's armband.
11. Refunds or cancellations due to judge change, overpayment of entries or cancellations made prior to entries closing will be mailed to said exhibitor or agent after the date of the show. There will be a processing fee of \$5.00.
12. Returned checks do not constitute a valid entry fee. The Club will add a Service Fee of \$10.00 to the amount of each returned check. Subsequent entries from the same Exhibitor or Agent will result in their being placed on a CASH ONLY basis for show entries.
13. Entries will be acknowledged after the closing date. The judging program and an entry acknowledgement will be mailed to entrants at least one week prior to the show. Please notify the Show Secretary of non-receipt of notices.
14. The Club is not responsible and is not obligated to furnish any service for notifying exhibitors or their agents of judging. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called. The judge will not wait for any dog holding up a class. Dogs should be on the show grounds no later than ½ hour before judging. Consult judging program for time of judging. Dogs not required for further judging will be excused after their class is judged.
15. Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
16. UNENTERED DOGS WILL NOT BE ALLOWED AT THIS OBEDIENCE/RALLY TRIAL.

LOSS OR DAMAGE

The Trial Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in this event.

The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of this event.

All persons attending this event hereby waive any claim from damages against the Obedience Training Club of Hawaii, or its members, in the event a motor vehicle has to be entered to rescue a dog from overheating for improperly vented conditions.
